In her role, Deb managed teams of hundreds of employees and learned first-hand how local business and workers are affected by health care affordability issues and other safety net issues.

After her time in the private sector, Deb was called to serve her community again. She became a Social Studies teacher at Conestoga High School and taught government, economics, and world cultures to thousands of students. As an educator, she understands what our children need to succeed as adults and citizens in the 21st Century and is eager to bring that fight to Harrisburg.

Deb believes in common sense solutions to the problems facing Pennsylvania. In her classroom she asked students to look for the solutions that unite us rather than the problems that divide us. She learned in both the Marines and in the classroom that we can't ignore the tough problems – we have to face them head on. Deb will work tirelessly to fix education funding so that every public school has the funding it needs. Deb will take on the entrenched interests who believe that politicians should draw our district boundaries, and will fight for fair districts. She will fight to give every Pennsylvanian access to affordable, high quality health care, and will work to create a Pennsylvania that attracts good jobs at good wages to the state.

### PUBLIC EDUCATION

Pennsylvania is 47th in the country when it comes to funding public schools. Deb taught at Conestoga High School for 19 years and has seen the difference that a great education can make in the lives of our children. She is committed to working to increase funding for all public schools in Pennsylvania so that they can provide a 21st-century education for all kids.

Deb is also committed to reducing standardized testing and restrictive educational policies.

### GUN VIOLENCE

As a teacher, Deb discovered after the Parkland shooting that she did not have the ability to keep her students safe. That's why she strongly supports common sense gun safety reform.

In an article she produced for Time Magazine, Deb wrote: "Let's not talk about school shootings in terms of gun control and mental health. Let's talk about school safety. Let's talk about whether we as a society have the will to keep our precious students safe in the place that most demands safety. It's about getting all the stakeholders in a room: parents, teachers, police, politicians and students, rather than asking teachers to carry the entire load."

## HEALTH CARE

Hard working Pennsylvanians deserve access to good quality health care. In her career as a teacher, Deb has seen the increased anxiety and depression in today's young people. ## ENVIRONMENT

Deb has been fighting for the environment since she marched for the passage of the Endangered Species Act on the first Earth Day. In office, she will advocate for sensible environmental policies that will not only benefit Pennsylvania's citizens, but also protect the state's resources and produce green jobs. Deb will also fight for a moratorium on fracking in the county until oil and gas companies have provided safety plans and protocols for these processes.

## ABOUT THE OPPONENT

Republican Christopher Quinn was elected to represent this district in 2016. Most recently, Quinn has voted repeatedly to hasten Pennsylvania's reopening, endangering the state's workers and broader population even as the incidence of COVID19 continues rising nationwide. Over the years, Quinn has taken anti-choice votes that have earned him a 0% rating from [Planned Parenthood Pennsylvania](#). He has also voted in favor of expanding gun access, including having voted for a bill to [arm security guards](#) in schools.

## WHY THIS RACE IS IMPORTANT

To flip PA's lower state legislative chamber, Democrats need to win 9 House seats. Momentum is on our side: in 2018, Democrats broke a Republican supermajority in the Senate and flipped a dozen State House seats. We can build on this energy to flip the chamber in 2020. Flipping a chamber in the PA legislature would give Democrats a critical seat at the redistricting table, particularly for Congressional redistricting. Republican state legislators have brutally gerrymandered PA's Congressional districts. And the political commission in PA that draws state legislative maps has also permitted terribly gerrymandered maps. We can prevent this from happening again by flipping a chamber and ensuring that Democrats have a voice in the next round of redistricting. Flipping a chamber blue is especially important because the PA Governor does not have veto power over state legislative maps. So while Democratic Governor Wolf will be in office during the next round of redistricting, we'll still need Democratic control of a chamber to have a say in the outcome.

**These are 'last chance' races: whoever is elected to the PA state legislature in 2020 will draw the next round of district lines.**

## REDISTRICTING & GERRYMANDERING

In Pennsylvania, Congressional district lines are drawn by the Pennsylvania General Assembly. State legislative lines are drawn by a five-member commission, the first four members of which are appointed by the majority and minority leaders of the State House and Senate, with the chair being appointed by either these four members or the State Supreme Court.

After the last round of redistricting, the Republican State House Majority Leader presided over a [piece of legislation](#) that remapped the state, resulting in extremely gerrymandered Congressional maps. For instance, Pennsylvania's 7th Congressional District was one of the most gerrymandered districts in the country, before the [Supreme Court declared it unconstitutional](#) in 2018. The district gained national notoriety as one of the most obvious efforts to gerrymander. The 7th District was so egregious that it earned a nickname, based on the cartoon characters it resembled: "[Goofy Kicking Donald](#)". The net result of the GOP's manipulations was a state that voted majority Democrat, but which sent thirteen Republicans to Congress and only five Democrats. Fortunately, the Pennsylvania Supreme Court ruled in 2018, after three elections conducted under this travesty, that the 2011 district maps were illegally partisan, and when the state's legislature could not agree on new district boundaries, the Court provided districts of its own. Unfortunately, the state legislative maps remain gerrymandered in favor of Republicans - as [an example](#), in 2018, Pennsylvania's Democratic State House candidates received 54% of the vote, but only won 45% of the seats.

### BROADER 2020 OPPORTUNITIES

- Pennsylvania is a critical, perennial battleground presidential state. Before Trump won the state by 44,000 votes, or less than 1%, Pennsylvanians had voted for the Democratic Presidential nominee in every election since 1992. Pennsylvania is one of the “Big Four” states that are likely to control the outcome of the 2020 presidential election. Democrats have a tremendous opportunity to claim PA’s 20 Electoral College votes this year, with smart organizing, expanding the electorate through voter registration, and turnout efforts.
- There are also several important, very competitive Congressional races in PA this year (including PA-10, PA-08, and PA-01, PA-07, PA-17, and PA-16).
- Working to support PA state legislative candidates will be instrumental in helping drive turnout up and down the ticket in this historic election year.
