LEGISLATIVE WORK

RAZE focuses on strengthening legislative engagement by empowering rural communities and fostering civic participation. RAZE prioritizes youth leadership development by involving young leaders from rural communities in legislative advocacy efforts, including participation in advocacy days at the Capitol, where critical issues aligned with their mission take center stage. RAZE educates residents on legislative developments and provides resources that equip community members with the tools and knowledge needed to actively participate in the legislative process.

Throughout the year, RAZE in collaboration with its sister organization RAZA, shares legislative updates and celebrates key policy advancements that benefit rural communities.



In 2024:

- RAZE supported and helped pass Proposition 139 to enshrine abortion access in the Arizona State Constitution.
- RAZE gained a defensive victory in opposing Proposition 137. This proposition would have eliminated judicial retention elections and term limits for judges.
- As a part of their work on immigration justice, RAZE took a position against Proposition 314 that criminalizes immigration and empowers state law enforcement to engage in racial profiling, however the proposition passed.
- RAZE achieved significant progress in advocating for groundwater conservation and regulation in Arizona, particularly in the Willcox Basin, where the Arizona Department of Water Resources recently proposed establishing an Active Management Area—the state's primary tool for regulating groundwater use.

ACCOMPLISHMENTS

In 2024, RAZE made significant strides in empowering rural Arizona communities through a series of impactful initiatives. The following accomplishments reflect their unwavering commitment to advancing equity and representation for rural communities across Arizona.

- The RAZE Leaders program has made significant strides in Pinal and Yuma counties. Since its inception RAZE Leaders has supported over 200 high school students in leadership development and civic engagement activities. In 2024, a key milestone was the establishment of "Building Healthy Futures for Youth," a rural-focused youth mental health forum in Pinal County, drawing 48 attendees, including youth, parents, and professionals, to address this critical issue.
- Deepening their work with Elections Protection from 2022, in 2024 RAZE mobilized 79 poll monitors on election day in 6 different counties and 24 polling locations for a combined total of 611.5 hours.
- RAZE's environmental justice team collaborated with stakeholders and activists to promote groundwater regulation legislation, engaging 12,026 new voters through mail, phone banks, canvassing, and social media.
- From Fall 2023 through July 2024, RAZE focused on engaging Arizona's most rural and often overlooked or suppressed communities. These efforts resulted in registering 7,630 rural voters and knocking on 178,695 rural doors.

ISSUES OF IMPORTANCE

RAZE's community trust programming is designed to better address and combat the disinformation detrimental to the New American Majority and engage rural communities in civic participation. They accomplish this while expanding the human infrastructure through strategic and engaging programs:

- 3. Community resource and protection
 - Community Give/Get Fund
 - Immigration Justice
- 4. Census Base Building
- 5. Environmental Justice
 - Rural Electric Co-Ops
